## Brief Profile of Mr. Goutam Ghosh

Mr. Goutam Ghosh has held operational and strategic roles in offshore exploration, development & production in national and international companies viz., ONGC, TOTAL, TATA, ARCO, BG and Shell. In a career spanning over 35 years, he has worked and lived in India, USA, France and UK and has successfully led multinational teams in large operated ventures to deliver as per global standards.

Before taking over his current role in MGL, he was Head, HSSE & Assurance, BGEPIL (a part of the Royal Dutch Shell plc group of companies) and a member of the Asset Leadership Team of BGEPIL since 2011.
