The length of pipeline will be 230 metres. The pipeline will be used of grade API-5L Gr. B of Diameter 12 NB", 9.5 mm thickness and 4" NB 6.4 mm thick steel pipeline crossing river lay together by HDD Method. The pipeline shall be laid at a depth more than 2.5m from the water bed.

In view of this it is thought prudent to re-examine MGL's proposed alignment & exploring the possibility of laying gas pipeline at opposite side of creek. The proposal will be submitted to CRZ accordingly for revised alignment.
