#### **Experience Criteria required for Empanelment**

- 1. The contractor shall have experience in any one of the following categories:
- (i) Laying of underground pipelines for carrying Hydrocarbon products / Water / Drainage / Sewage jobs, laying of Underground Duct/ Cable through the method of open excavation.
- (ii) Installation of above ground water pipe line, Gas Pipe Line/ firefighting system / process plant piping /LPG reticulated system, Construction of Residential/commercial / institutional Building involving Plumbing activities, façade cleaning or any other activity involving Working at Height.
- (iii) Laying of underground Steel Pipe Line for carrying Hydrocarbon product of size 4" NB to 12" NB or above of minimum length of 8 Km.

In addition to the documents sought in the Empanelment form, the following documents shall mandatorily be submitted along with application form:

- a) Copy of Work Orders for Jobs mentioned at Point (1) above.
- b) Copy of Work Completion Certificate from client or any other equivalent documents.
- c) Experience Certificate from client if available.
- d) Applicants who have experience as a Subcontractor shall submit work experience certificate signed by the client for whom the work has been carried out. The certificate issued by the main contractor without endorsement by client will not be considered.
- e) PF & ESIC Registration Certificate
- f) Service Tax, VAT and GST Details.
- g) Details of Manpower along with Organogram
- h) Copy of Audited Balance Sheet and Profit and Loss account of last three financial years.
- i) Safety Policy of Company.

Contractors who do not possess experience as indicated above but have experience in the any other related field and are willing to work with MGL for these jobs may also apply. However, MGL reserves the right to accept or reject the applications depending upon merits /credentials of the applicant.

MGL also reserves the right to relax the above criteria in its own Business Interest without assigning any reason. Merely meeting the above criteria shall not entitle applicant for empanelment with MGL. MGL shall consider all other requirement as stipulated under terms and condition & Empanelment form for considering applicant for empanelment.

MGL shall do the evaluation of applicants based on the documents submitted by the applicants and may categorize them based upon execution capability, financial credentials, Safety and Performance track record, feedback from clients etc. Once the empanelment process is completed, the applicants who will be empaneled shall be intimated.

# **Brief Scope of Work**

The brief scope of work is given below for the purpose of understanding. The detailed scope of work shall be provided at the time of Tender.

Scope of work shall be but not limited to :

## Laying of PE Job:

Laying of Medium pressure PE pipeline on Municipal corporation/Private Roads, Road crossings, Permanent reinstatement of Private road, Protection of PE pipeline through RCC tiles, U Block & Bottom slabs. Construction of valve chambers & Installation of PE stop off valves and Laying of PE pipe below the drains/culverts/Nallahs. Installation of regulators, obtaining necessary statutory permissions, installation at premises of customer as per MGL safety standards.

#### GI & LMC Job:

Laying of Low pressure PE pipeline, Erection of above ground threaded and welded GI pipes in residential complexes, commercial establishments, Erection of GI online connections from gasified risers in residential & commercial buildings using work at height (safety rope access system), Installation of domestic gas meter, Meter regulator, Erection of copper tube inside kitchen & conversion of Gas burners, Installation of Commercial gas meter, regulator.

#### **Online Connection Job:**

Online Tap off (GI pipe) from Gasified riser, Installation of ERW/GI pipe, Installation of Copper Pipe, Installation of regulator, Gas Meter, Rubber Hose, Valves etc. for supply of Piped Natural Gas inside the Kitchen for Domestic Customers.

## Steel Pipe Laying Job:

Laying, Testing and Commissioning of underground 4" NB to 12" NB Carbon steel Pipeline, with associated facilities including valve chamber assembly, DRS, hook-up with existing pipelines, tap off from the existing /proposed Tap-off points. Aboveground Pipe fabrication, Structural fabrication, Valve Installations, city gate station installation, Valve Pits / Valve chambers preparation, wherever required. Installation of pipeline by crossings of road, utilities, underground pipelines & water bodies (river, drain, Stream, Culvert, Nallah etc.) through open cut or by trenchless method.
