Sub: Diversion of 0.7605 ha Reserved Forest Land in favour of Mahanagar Gas Limited for Laying 12" dia NB Steel and 125mm MDPE underground Pipe Line for transportation of CNG and PNG for Mumbai and Thane consumer in Tal. & District Thane in the State of Maharashtra- Regarding.

Sir,

The undersigned is directed to refer to State Government letter No. FLD-1219/C.R.180/F-10 dated 12.06.2019 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/NC/II/ID 12709/(68)/125/2019-20 dated 02.05.2019 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and Nodal Officer (FCA), Maharashtra letter no. Desk-17/NC/II/ID 12709/(68)/1962/2019-20 dated 29.02.2020 & letter No. Desk-17/NC/II/ID 12709/(68)/650/2020-21 dated 21.10.2020 forwarding additional information as sought by this Office vide letters of even number dated 26.06.2019 and 06.04.2020 and to say that the said proposal has been examined by the Integrated Regional Office in light of relevant provisions of the Forest (Conservation) Act, 1980 and Guidelines issued thereunder.

After careful examination of the proposal and on the basis of the recommendation of APCCF & Nodal Officer (FCA), Maharashtra, the Central Government hereby accords 'in-principle' approval under Section - 2 of the Forest (Conservation) Act, 1980 for diversion of 0.7605 ha Reserved Forest Land in favour of Mahanagar Gas Limited for Laying 12" dia NB Steel and 125mm MDPE underground Pipe Line for transportation of CNG and PNG for Mumbai and Thane consumer in Tal. & District Thane in the State of Maharashtra subject to the fulfilment of the following conditions:

- i. Legal status of the forest land shall remain unchanged;
- ii. **Compensatory afforestation:**

Cost of plantation (including ten years maintenance) of ten times the number of trees likely to be felled shall be levied from the User Agency towards Compensatory Afforestation. As far as possible, a mixture of local indigenous species along with 10% RET species of Thane District shall be planted and monoculture of any species may be avoided;
- iii. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the

Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years;

iv. **NPV:**


- a. The State Government shall charge the Net Present Value (NPV) for the 0.7605 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard;
 - b. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect;
- v. User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department;
- vi. All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through *e-portal* (<https://parivesh.nic.in>);
- vii. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector;
- viii. The pipeline shall be laid down 1.5 meter below the ground and after lying down of pipe line the ground will be leveled.
- ix. User Agency shall develop a separate nursery at one or more places to raise at least 2500 seedlings of forestry species along with bamboo, fruit bearing, medicinal, ornamental and indigenous/local every year. At least 50% of seedlings shall be planted by User Agency in the vicinity of project area including forest area and for better relation with local people residing in vicinity of proposed road, User Agency shall voluntarily distribute remaining 50% of seedlings to them free of cost. A compliance report including species wise details of seedlings raised, location of plantation area and details of villagers whom seedlings have been distributed need to be prepared every six month and submitted to Regional Office of MoEF&CC;
- x. The User Agency shall ensure the compliance of the conditions prescribed by the Standing Committees of the NBWL and SBWL;
- xi. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
- xii. The layout plan of the proposal shall not be changed without prior approval of Central Government;
- xiii. No labour camp shall be established on the forest land;

- xiv. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- xv. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer;
- xvi. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- xvii. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- xviii. The forest land shall not be used for any purpose other than that specified in the project proposal;
- xix. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
- xx. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018;
- xxi. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
- xxii. The compliance report shall be uploaded on *e-portal* (<https://parivesh.nic.in/>).

After receipt of a report on the compliance of conditions no iii, iv (a), vi, vii, x and undertakings, duly authenticated by the competent authority in the State Government, in respect of all other conditions, from the State Government, formal approval will be considered in this regard under Section-2 of the Forest (Conservation) Act, 1980.

Order:-

Whereas, the Additional Principal Chief Conservator of Forests & Nodal Officer, Maharashtra State, Nagpur, vide letter under reference no.1 has submitted a proposal for diversion of 0.7605 ha. Forest Land in favour of Mahanagar Gas Ltd., Mumbai for laying of underground pipeline for transportation of CNG & PNG in Thane District of Maharashtra;

AND whereas, the Government of Maharashtra, vide letter under reference no.2 after careful scrutiny and consideration, has recommended it to the Government of India to divert the 0.7605 ha. Forest Land for the above project under section 2 of Forest (Conservation) Act, 1980;

AND whereas, the Government of India after due consideration, vide letter under reference no.3, granted in-principle approval to divert the 0.7605 ha. Forest Land for the above project under section 2 of Forest (Conservation) Act, 1980. The said approval is subject to fulfillment of certain conditions by the User Agency;

AND whereas, the Additional Principal Chief Conservator of Forests & Nodal Officer, Maharashtra State, Nagpur vide letter under reference no.4 has submitted compliance of those conditions to the Integrated Regional Office, Ministry of Environment, Forests & Climate Change, Government of India, Nagpur;

AND whereas, the Integrated Regional Office, Ministry of Environment, Forests & Climate Change, Government of India, Nagpur, vide under reference no. 5 accorded 'final approval' to divert the 0.7605 ha. Forest Land for laying of underground pipeline for transportation of CNG & PNG under section 2 of Forest (Conservation) Act, 1980;

AND whereas, the Additional Principal Chief Conservator of Forests & Nodal Officer, Maharashtra State, Nagpur vide letter under reference no.6 has requested State Government to issue diversion order in the matter;

NOW, therefore, Government of Maharashtra hereby directs that the forest land area of 0.7605 ha. of consisting of Private Forest, Forest (Unclassified) & Reserved Forest Land more specifically described in the proposal submitted vide letter under reference no. 1 and as per details given in the Schedule given below, be diverted to the User Agency, i.e. Mahanagar Gas Ltd., Mumbai for laying of underground pipeline for transportation of CNG & PNG in Village-Chene & Bhaindarpada, Taluka & Dist. Thane. The diversion shall be effected subject to the terms and conditions mentioned in the letters dated 30.10.2020 and dated 26.10.2021 of Government of India. This approval for diversion of forest land is also subject to compliance of following conditions by the User Agency-

1. The User Agency shall comply with all the conditions stipulated in the 'in-principle' and 'final approval' letters of Government of India, referred above. The Director, Sanjay Gandhi National Park, Borivali shall ensure the strict compliance of the conditions by the User Agency and shall furnish the report in this regard to Additional Principal Chief Conservator of Forests and Nodal Officer, Maharashtra State, Nagpur from time to time.
2. Non-compliance of any of the conditions mentioned in Government of India's letters dated 30.10.2020 and dated 26.10.2021, in this order and Rules and Guidelines made / issued under Forest (Conservation) Act, 1980, shall amount to violation of Forest (Conservation) Act, 1980 and action would be taken accordingly.
3. In case of non-compliance of any of the above conditions, the Director, Sanjay Gandhi National Park, Borivali shall report through the State Government to the Regional Officer (Central), Ministry of Environment, Forests & Climate Change, Government of India, Nagpur as per procedure laid down under guidelines under the Forest (Conservation) Act, 1980.
